International Citation in the qualification of Doctor

Article 18. International citation in the qualification of doctor

1. The qualification of doctor may include on the reverse the citation "International Doctor" under the following concurrent circumstances:

- a) That during the mandatory training period to obtain the qualification of doctor, the candidate spent a minimum of three months out of Spain in a higher education centre or prestigious research centre taking courses or undertaking research tasks. The fellowship may be carried out in different centers, and in periods of at least 30 days as long as there are reasons that justify it in the opinion of the Academic Committee. In general, stays may not be carried out in institutions in the country of origin, residence or work of the doctoral student. In any case, the stay and activities must be endorsed by the director and authorized by the Academic Committee and will be incorporated into the document of activities of the doctoral student.*
- b) That part of the doctoral thesis, at least the abstract and conclusions, are written and presented in one of the common languages for scientific communication in their field of knowledge, different from any of the official languages in Spain. This criterion will not be applicable when the stays, reports and experts are from a Spanish-speaking country.*
- c) That the thesis has been informed by at least two expert doctors from a non-Spanish higher education establishment or research institute. Only one of these experts may have been part of the thesis evaluation panel.*
- d) That at least one expert belongs to a non-Spanish higher education establishment or research centre, holding the title of doctor, and other than those responsible for the stays, has been part of the thesis assessment tribunal.*
